

I look forward to learning and growing personally and strengthening our organization while we move forward.




## MARK YOUR CALENDARS!!

The 2018 election of officers was conducted during our Spring Educational Seminar. Congratulations to our new President Pam Lawn, who is replacing Lynn Bonner (Past President). Congratulations as well to the new Vice President Nancy Wilson and a new Member-At-Large Matt Noonan. In addition, Anitra Brown-Reed was reelected as Member-At-Large and Caroline Friel was reelected as Associate Representative.

### **Educational Seminars**

Our SPRING EDUCATIONAL SEMINAR was held on March 23, 2018 at the Montgomery County Public Safety Training Campus Auditorium, 1175 Conshohocken Road, Conshohocken, PA 19428.

Scott Hood, Ph.D., presented "Pathogens in Flour – Insight from the 2016 Recall". Dr. Hood is the Director of Global Scientific & Regulatory Affairs at General Mills Inc. in Minneapolis, MN. In the summer of 2016, General Mills recalled several types of flour due to illnesses from a strain of *E. coli*. Over 50 illnesses were linked to eating uncooked dough and batter made with raw flour. Dr. Hood explained the difficulty in determining the source of the pathogen. Wheat is grown in open fields and is often stored on the ground outside. Flour is not typically treated to kill bacteria during a normal milling process. Dr. Hood described General Mills' efforts to mitigate risk, such as by emphasizing sanitation and by controlling yield. He also stressed collaboration between industry partners and government agencies. Dr. Hood described his company's goal of educating consumers not to eat raw cookie dough or cake batter (e.g. by prominent labeling).





Jack Welte presented "Species Substitution" regarding seafood. Jack is a Sanitarian with the PA Department of Agriculture, Creamery, PA. Seafood substitution is a type of economic fraud when a less expensive species is substituted for a more expensive species. The motivation is an increased profit margin for a retail store or restaurant. The harm is that a consumer is not receiving what he/she was promised (e.g. mako shark for swordfish). Jack presented many examples of species substitution and described tips for detection as both a regulator and consumer.

Kyle Hobson, REHS, presented "Norovirus: An Overview of Outbreaks and Prevention". Kyle is an Investigator with FDA, Office of Regulatory Affairs, Human & Animal Food Division 2 East in the Wilmington, DE Resident Post. He described symptoms, associated foods, and control measures for norovirus. Norovirus, or the "winter vomiting bug", is a very common cause of gastroenteritis characterized by diarrhea, vomiting, and cramping. The virus is usually spread by the fecal-oral route (e.g. contaminated food or water or person-to-person contact). Kyle illustrated how easily norovirus can be transmitted. Insanitary food preparation is a risk factor. Kyle

stressed the importance of prevention via proper hand washing and disinfection of contaminated surfaces.

James Massey presented "The Importance of Integrated Pest Management". Mr. Massey is an Independent Food Safety Inspector based in Upper Chichester, PA. He described the risks associated with pest entry and resulting food contamination in manufacturing plants and retail outlets. Mr. Massey explained how an effective pest control system can exclude the little critters and protect the food, thereby protecting the company's business reputation as well as the public's health.



## **FDA News**

On July 26, 2018, FDA issued its first Warning Letter regarding the new Preventive Control regulations for human food in Subpart C of 21 CFR 117. This advisory action was taken against a contract manufacturer of a brand name cereal. The cereal was linked to a multistate outbreak of Salmonella illness; it was then recalled. The incident illustrates the importance of developing and implementing a Sanitation Control Program to protect ready-to-eat food from contamination when it is potentially exposed to environmental pathogens in the facility. In this situation, environmental monitoring should be performed to verify the effectiveness of sanitation procedures.
