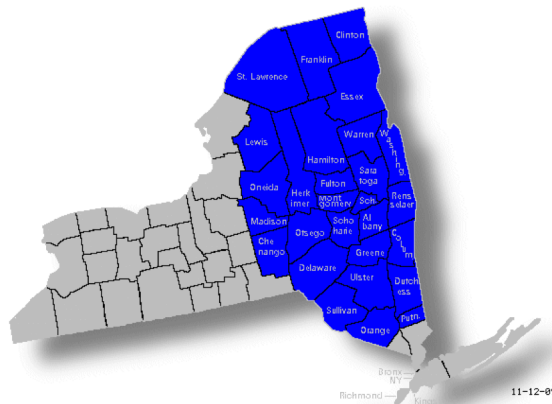

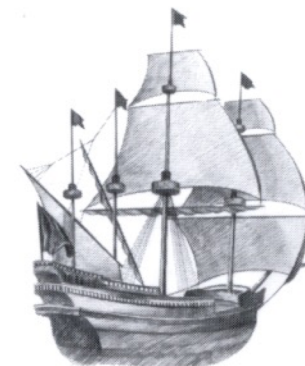

COMMITTEES:

We are always looking for participation in these committees. Please see a Board representative if you are interested.

Associate Committee- Provide input to all standing CASA committees as needed. Assist with providing potential speakers and topics for conferences.

Communication Committee- Maintain an active website, to include posting of educational opportunities and conference event information. Update information on committee activities which will be reported on the website. Advise the executive board of options or concerns relating to the website that will improve the professional appearance of the website and make it user friendly.

Constitutions & By-Law Committee- Review the CASA Constitution and By-laws to recommend any needed or suggested changes to the Executive Board and prepare a draft of the update, if necessary, to the CASA secretary by March 1st for submittal to the Executive Board and subsequent posting to the website for membership review.

Drugs Committee- Advise the Program Committee on drug-related subjects for the Annual Education Seminar. Cooperate with the Food Committee by advising them of proposed or finalized legislation and concerns about "inconsistent" laws or regulations.

Food Committee- Be prepared to study food issues as they emerge or as directed by the Executive Board of CASA. Suggest training needs as they relate to food issues to the Executive Board.

Laboratory Committee- Be prepared to study laboratory related issues as they emerge or as directed by the Executive Board. Suggest training needs to the drug, food and education committees as they relate to laboratory issues.

Membership Committee- Undertake activities in local conferences in the spring to identify and follow up with members who have not renewed membership. Try to achieve a goal to increase over last year's membership. Determine the approach needed to attract more members from academia and share with all conferences. Undertake appropriate activities to increase CASA. Assist CASA Executive Board in membership activities.

Nominating Committee- Submit candidates for positions to the President, as required by the Constitution and by-laws, by January 1st and follow the voting process as prescribed by the C & B-L.

Resolutions Committee- Each committee member is encouraged to submit a call for resolutions to their local conference members. Local conference proposed resolution should be sent to the Executive Board in the appropriate format by March 1st for review.

Water Committee- Be prepared to study water related issues as they emerge or as directed by the Executive Board. Suggest training needs to the drug, food and education committees as they relate to water issues.
