

THE PRESIDENT'S MESSAGE



Conference News & Updates

At our Fall 2016 educational seminar, Jeanne Garbarino and Priscilla Lewis (from the Vineland City and Englewood, NJ Health Departments, respectively), along with Howard Rabinovitch (retired from FDA), demonstrated how the AFDO-administered Retail Program Standards and their related grants can inspire health departments to pursue improvement of their retail food programs. Good news – the 2018 Retail Program Standards Grant Portal is open until October 2, 2017! Barbara Kitay (from FDA's Office of Partnerships) reports that grant funding is open to state, local, territorial, and tribal regulatory retail food programs that have enrolled in the Retail Program Standards. Approximately \$1.4 million in funding is available for the upcoming granting year! Check out http://afdo.org/retailstandards for the most up-to-date information including application instructions.

Since the inception of the AFDO-administered Retail Program Standards Grant Program in 2014, more than \$4.9 million has been awarded across 1,119 grants, per the map below.
