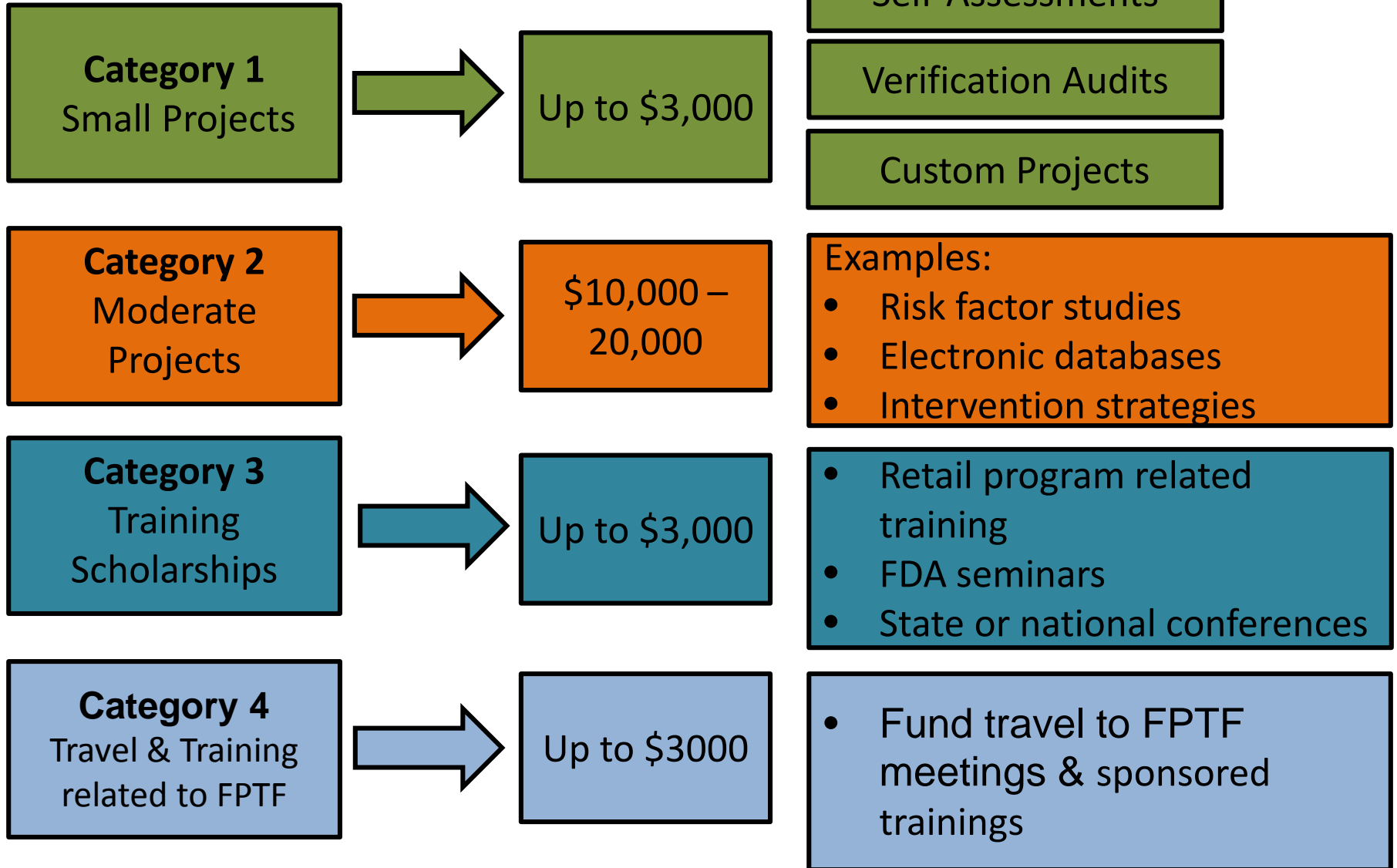
## Fall 2019 Application Period

# Retail Association Cooperative Agreement

- Can apply for up to one grant in each category; total of 4 per calendar year
- Can apply even if your program receives funds from other FDA sources (expected outcomes must be different)
- Simple application and reporting process

- Establish a growing network of retail food regulatory programs experienced in the implementation of the Retail Program Standards.
- Improve NACCHO and FDA's understanding of the technical assistance needs of retail food regulatory programs around the Retail Program Standards.

## NACCHO Mentorship Program

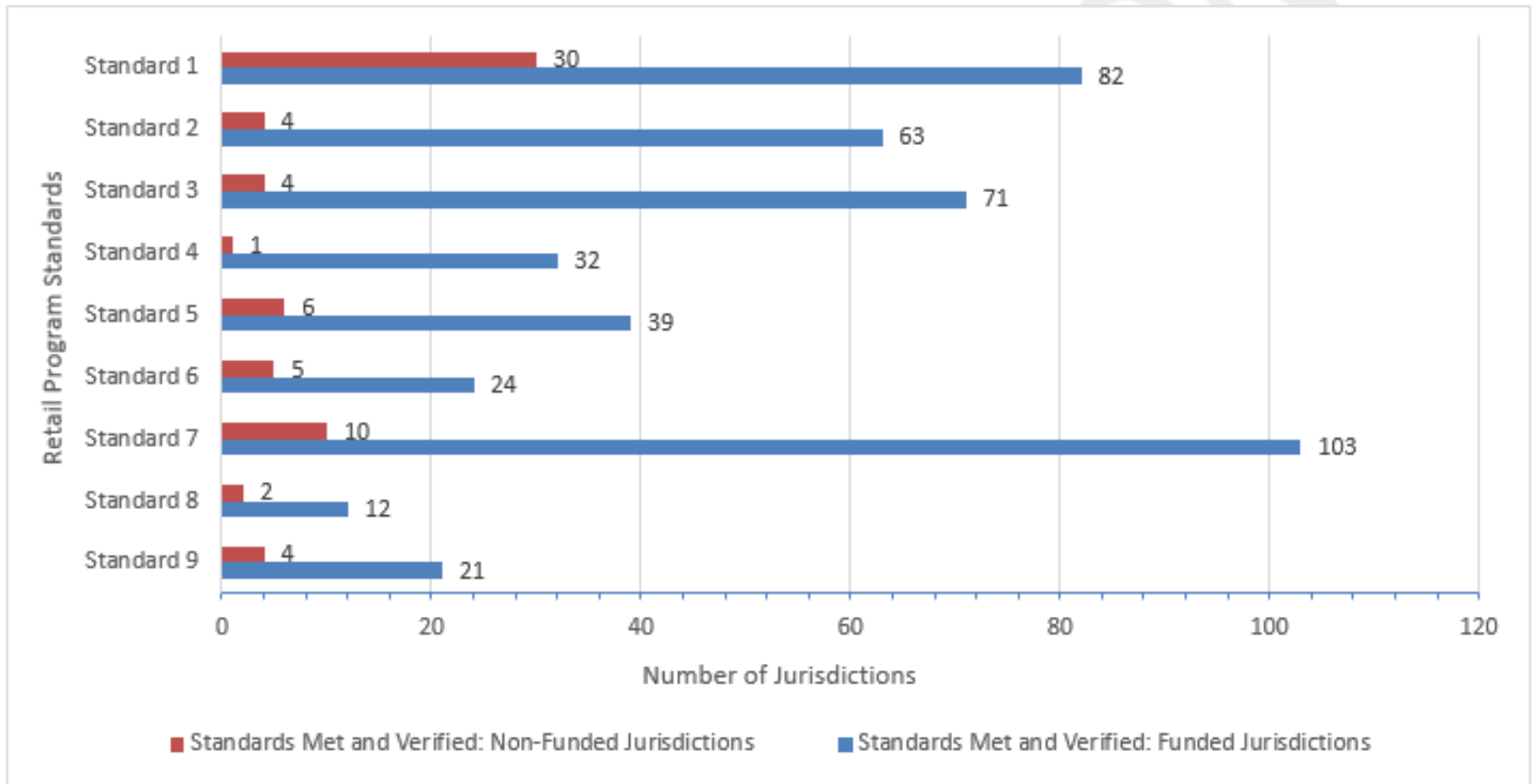

# What has been accomplished?

- Jurisdictions identified program areas that can have the greatest impact on retail food safety.
- Jurisdictions collaborated with mentorship to strengthen the “multiplier effect” to support an IFSS within the national retail food safety arena.
- Jurisdictions developed innovations in program implementation and administration of the Retail Program Standards.
- Jurisdictions improved industry and consumer confidence in food protection programs by enhancing uniformity within and between regulatory agencies.



# What has been accomplished?

- Fifty-one jurisdictions used CAP funding to develop a public health performance metric based on the occurrence of foodborne illness risk factors.
- Forty-one jurisdictions meet the Standard 9 criteria and have used risk factor studies to implement intervention strategies to address out of compliance food safety behaviors and practices identified in the study results (2013 – current).
